## Message From Grand Knight

A little over three years ago, I accepted an offer to become more directly involved with the duties and responsibilities needed to make our council the best that it can be. When asked to serve as the Chancellor for our council, I was aware of the possibility that someday if elected, I may serve as the Grand Knight of Council 1580.

The process of "moving through the chairs" came quickly, and as of July 1, 2014, I became your Grand Knight. As your leader, it is my primary responsibility to assure the successful conduct of this council with the ultimate goal of providing for "a better council." It is the Grand Knight's obligation to inspire mutual cooperation among officers and members.



On June 28th, three days before beginning my term, I received an email notification that there was an expression of interest from a company wishing to purchase a tract of land owned by our organization.

Five days later on July 3rd, during the executive board meeting for the Columbus Club, officers were asked to vote on whether to pursue this matter. This vote produced a unanimous decision to move forward. We have since received a letter of intent from KRB Universal Investments, LLC, a commercial developer to purchase a tract of land approximately 1 acre in size on the northeast corner of the property.

A notification letter has been drafted and sent to all Council 1580 membership regarding a special meeting to take place Monday, Nov. 10, 7:30 p.m. at the Hall. This special meeting will provide a forum for you to express your feelings and ultimately vote on whether or not to have the Columbus Club sign this letter of intent and begin negotiations with KRB. Although this is not a mandatory meeting, I would strongly urge all members to attend who would like to voice an opinion. For those of you who may be unable to attend, the notification letter includes a ballot that you can complete and return to the KC Hall by noon Monday, Nov. 10. As your leader, I feel that I would be remiss in my duties if I did not provide you with some of my thoughts and feelings concerning this matter which is of the utmost importance and in need of careful consideration.

I am against moving forward and entering into negotiations with KRB at this time for several reasons.

- These reasons are as follows:
- We are not financially insolvent. The council and the club have adequate cash flow to conduct normal business and meet financial obligations. If the council and the club exercise fiscal responsibility and make sound business decisions with input from key resources, we will continue to operate.
  - We do not have an assigned committee for this potential endeavor. In the past we have assigned officers to committees to look into printer purchases, ice machines and flooring tile; however, there is no such committee assignment for a proposal of this magnitude.
  - We do not have a detailed business plan stating how to go about; developing and implementing strategies and measuring results. We have not been presented with nor have we discussed all of the options available to us.
  - We do not have an agent to represent us. The agent currently mentioned has a fiduciary responsibility to the prospective buyer only. A dual-agency form of representation should not be utilized.
  - Time constraints. We do not have enough time to research the contents of the proposal to make an informed decision.
  - Once it's gone – it's gone! If we decide to sell the parcel of land as proposed, we can never get it back. We will not be able to control what type of business will locate on the property.

For these reasons, I believe it is in the best interest of our council not to pursue the proposed land sale. That being said, I am not against looking at future real estate opportunities. I believe with a clear mission, diligent research, professional representation and first and foremost, the input and support of council membership, we can assure that our organization will continue to grow and prosper for a long, long time.

## KNIGHT OF THE MONTH

He is presently directing and coordinating the AED training of the Hall employees, as well as Council members who may be interested in the training to save lives.

The Knight has recently retired as a volunteer fire-fighter, having served as an assistant chief, driver, hose-handler and safety trainer over that time in service to the community.

The Knight we have selected is a dedicated family man, having his children graduate from the St Paul Elementary School. He gives unlimited attention to his family, and assists his mother-in-law to attend Holy Mass.

Our Knight of the Month demonstrates his commitment to the Church as a member of St. Paul Parish of Highland, a captain of the hospitality ministry, a greeter himself. This Knight offers his home and skills for good fun, for fundraising programs that generate cash for the parish through the Kirchenfest auction. He has chaired and served on several Kirchenfest functions with his family.

Remember, this is for our future priests who need and deserve our support.

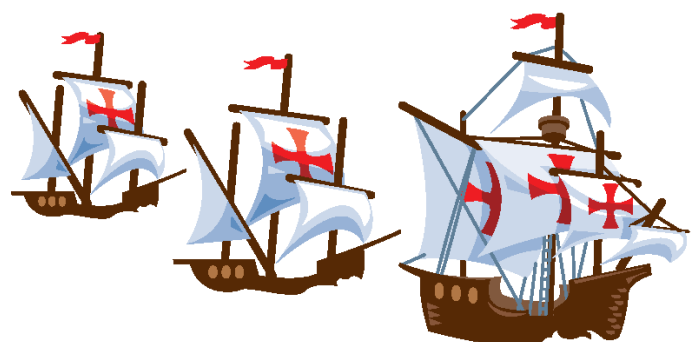
Locally we are providing assistance to Reverend Mr. Samuel Bagyo and seminarian Mr. Rafal Pырchla.
